**The Board of Ingenico acknowledges the current absence of a binding offer
on its share capital**

The Board of Directors of Ingenico, after receiving a non-binding offer on December 14, 2010, has reviewed the content and the terms with the Acquirer. At this stage of the discussions, the latter has not been in a position to submit a binding offer that could be accepted by the Board.

Consequently, the board has taken note of this current situation and has asked for the trading of the Ingenico share (Euronext: FR0000125346 - ING) to resume on Euronext Paris on Monday December 20th.
